Match Day Process

Required Timeline for notification is dictated by the governing associations. Each year the responsible officer is to reference the associations for required dates and communicate to required stakeholder

It is the Facilities manager and Secretary's responsibility to understand the associations wet weather process and requirements prior to the commencement of each season.

Training Day Process

Due to travel distance that some of the players and coaches must undertake to participate in training, field closures are required to be communicated prior to 1pm.

During the inspection of all fields; If some fields are acceptable for training then the **Priority training use schedule** should be reference and the coaches for those teams be notified
